I hereby represent and warrant that the foregoing information is true and correct and hereby make application for membership in Central Utah Barrel Racing, and in consideration of the granting of said membership, I hereby agree to abide to all by-laws, rules, and regulations adopted by said organization.

WAIVER: I acknowledge that participation in horse and stock events at any arena may be an extreme test of a person's physical and mental limits and carries with it the potential for death, serious injury, injury to animals, and property loss. The risks include, but are not limited to, those caused by terrain, facilities, water conditions, including pollution, temperature, weather, conditions of equipment, vehicular traffic actions of animals and/or stock, actions of other people including but not limited to participants, volunteers, spectators event officials and event monitors and /or producers of the event and the lack of hydration. I hereby assume all of the risks of participation in events held by Central Utah Barrel Racing. I certify that I am physically fit have sufficiently trained for participation in this event and have not been advised otherwise my qualified medical person.

I acknowledge that this Accident Waiver and Release of Liability (AWRL) form will be used by Central Utah Barrel Racing and the event holders, sponsors, organizers, and arenas in which I may participate and that it will govern my actions and responsibilities at said events. In consideration of my application and permitting me to participate in this event, I hereby take action for myself, my executors, administrators, heirs, next of kin, successors, and assigns as follows: (A) Waive, Release, and Discharge from any and all liability for my death, disability, personal injury, property damage, property theft of action of any kind which may hereafter accrue to me or my traveling to and from this event: Central Utah Barrel Racing and its directors, officers, volunteers, representatives, and agents, the event holders, event sponsors, directors, and arenas. (B) Indemnify and Hold Harmless the entities of persons mentioned in the paragraph from any and all liabilities of claims made by other individuals of entities as a result of any of my actions during this event. This Waiver and Release shall be construed broadly to provide a release and waiver to the maximum extent permissible under applicable law.

In reference to **Utah State Law 78-276-102 Equine and Livestock Activity Liability Limitations:** It shall be presumed that participants in equine or livestock are aware of and understand that there are inherent risks associated with these activities. An equine activity sponsor, equine professional, livestock activity sponsor, or livestock professional is not liable for an injury or to the death of a participant due to the inherent risks associated with these activities, unless the sponsor or professional: provided the equipment or tack: the equipment or tack caused the injury; and the equipment failure was due to the sponsor's or professional's negligence; failed to make reasonable efforts to determine whether the equine or livestock could behave in a manner consistent with the activity with the participant; owns, leases, rents, or is in legal possession and control of land and or facilities upon which the participant sustained injuries because of a dangerous condition which was known to or should have been known to the sponsor of professional and for which warning signs have not been conspicuously posted; commits an act or omission that constitutes negligence, gross negligence, or willful or wanton disregard for the safety of the participant; and that act or omission causes injury; or intentionally injures or causes injury to the participant. This chapter does not prevent or limit the liability of an equine activity sponsor, an equine professional, a livestock activity sponsor, or a livestock professional who is: a veterinarian licensed under Title 58, Chapter 28, Veterinary Practice Act, in an action to recover for damages incurred in the course of providing professional treatment of an equine; liable under Title 4, Chapter 25, Estrays and Trespassing Animals; or liable under Title 78, Chapter 15 Product Liability Act.
